

## **Wicked Cool Toys Golden Ticket Sweepstakes**

### **Official Rules**

LAMO figures purchased from participating GameStop locations will include a QR code found inside the products. At the time of scanning the QR code 40 lucky winners will each receive a \$100 worth of LAMO in app download redemptions.
